Restored cannon from 1715 fleet adorns waterfront

At a festive downtown Fort Pierce event on Feb. 15, a restored ancient Spanish cannon was dedicated and placed on public display. There was a big crowd -- chairs set up at the edge of the St. Andrews ball field. St. Andrews donated the property to the city to be a home for our newest historic property, a cannon brought up from the Atlantic floor after 300 years.

The cannon was from the wreck of a Spanish galleon located north of the Fort Pierce Inlet that was leaving Cuba in 1715 loaded with the spoils of gold, silver and jewels from the country's South American colonies. Spain was in need of coin for their coffers to support the empire's extravagant lifestyle and endless wars.

A July hurricane sank the fleet off our coast sending a swath of treasure to the ocean floor from Jupiter to Sebastian. A gold fever to recover the riches began in my last years in high school circa 1960s-70s. And dreams

continue today for divers and seekers with metal detectors still search for the glitter and gleam of underwater prizes. Much of what has been retrieved heretofore is in private, public and state collections, some on display.

The cannon and explanatory plaque were unveiled by Mayor **Linda Hudson** along with other dignitaries including treasure diver **John Brandon**, who donated his time and skill in bringing up and treating the cannon for long-term display.

To visit the massive cannon look for it behind St. Andrew's Episcopal Church on Melody Lane at the corner near the marina fishing pier. $\,\Delta$

Creator of lurid 'dime novels' had early adventures in Florida

The Second Seminole War in Florida had its share of bold young military men who later rose to national fame, especially in the Civil War. One veteran of the Florida conflict, **Edward Zane Carroll Judson**, is sometimes overlooked by Florida historians. He became more famous for his writing than for his military record.

Judson, born in 1823 in a small New York village, was a young U.S. Navy midshipman from 1839-42. He served in the Florida Squadron patrolling the peninsula's southern coast, generally along Biscayne Bay, the Keys and the Ten Thousand Islands. He also ventured with his unit into the mysterious Everglades. He saw little combat, however.


After the war, Judson traveled widely and carved out a career as a newspaperman, public speaker and author, using the pseudonym **Ned Buntline**. He is known as the inventor of the "dime novel." They were short, cheap and action-packed. A series titled *The White Wizard*, or *The Great Prophet of the Seminoles*, drew on his wartime impressions of the Florida wilderness and its people.

His tales were exciting, but largely untrue. Some titles included *The Fiend of Blood, The Pirate King of the Floridas*, and *Scouts of the Plains*. To the public, Judson aka Buntline is mainly associated with thrilling tales of the American west, although only a relative handful of his novels had a distinctly western theme.

Judson roamed the country, getting into trouble almost everywhere. Historian Jay Monaghan, in a 1951 biography, calls Judson "The Great Rascal." He was an untrustworthy fellow, often in financial distress. Judson was married at least four times (including twice to the same woman), was narrowly saved from hanging after fatally shooting a man in a duel, and helped instigate a New York City riot in which almost two dozen people died.

Florida Fact

Spanish explorer **Juan Ponce de Leon** landed on April 2, 1513, reportedly near the mouth of the St. Johns River, although historians for years have disputed the exact location. Two other possible landing sites have been suggested — Ponce Inlet near today's Daytona Beach and, even farther south, Melbourne Beach. He named this land La Florida, after *Pascua Florida*, the Easter season festival of flowers.



During a Western trip Judson met frontiersman William F. Cody, dubbed him "Buffalo Bill" and wrote a series of stories – greatly exaggerated -- about Cody's career as a scout and hunter. This launched Cody's career as a star of wild-west shows.

Later in life Judson dabbled in politics and toured as a temperance lecturer, though he was often drunk. He continued to write, but couldn't hold onto money. He lied about many aspects of his tumultuous life, puzzling later biographers. His health also began to fail. At home in Connecticut, he died July 16, 1886 at age 63.

Member's contribution will repaint Gardner House inside

Modine's ranching saddle added to Adams-Cobb exhibit



The Bud Adams Gallery of Vintage Photographs in the old Cobb building downtown acquired a new exhibit item recently when SLHS board member **Rick Modine** lent his well-worn ranching saddle for display.

The saddle, plus an attached slicker and rope, have been added to the section devoted to cattle ranching memorabilia. Exhibit director **Jean Ellen Wilson** says that visiting children are especially fascinated by the saddle and accessories – another reminder of the cattle industry's historic importance to our area. Florida Fact

John Milton, Florida's fifth governor, fatally shot himself on April 1, 1865 at his home near Marianna. He was depressed over the South's defeat in the Civil War. In his final address to the Legislature he had declared, "Death would be preferable to reunion."

Echoes from our past

Browsing through old copies of newspapers and magazines can be a fascinating pastime. They give us intriguing glimpses of life in bygone times and how people coped with the challenges of daily living.

The following items were gleaned from editions of the *St. Lucie County Tribune* published more than a century ago.

An item from the Feb. 28, 1913 edition:

"C.D. Blakeslee, who manages the ferry at Stuart, was in [Fort Pierce] on Saturday. He asserts that the county [Stuart then was in Palm Beach County] should make some repairs on the ferry approaches because when the wind and the tide are in certain conditions the carrying of automobiles is very dangerous and difficult. There have been times when, with an auto weighing some 3,500 pounds, he has been forced to cruise for a couple of hours ere he dared to attempt the landing. It would require, so Mr. Blakeslee says, less than \$100 to make the landings safe and render things far more satisfactory."

From the same day's edition, this real-estate ad:

"Cottage and pineapple property, situated on a hill about 400 yards from and overlooking the Indian River, at St. Lucie, Florida, a favorite winter resort. About 200 yards from railway depot, also the new county rock road. Consists of five and one-third acres – three and one-half acres in pineapples ... crop for 1912 netted \$1,350, also three dozen grapefruit and orange trees. Everything about premises in first-class condition. A bargain at \$2,500 cash." A small photo showed a white frame cottage with a porch, surrounded by pineapples.

From the edition of March 21, 1913:

"A grand jury presentment says the St. Lucie County jail is in need of painting and some repair, including a fence, to prevent promiscuous visiting and talking with prisoners. ... We strongly urge that this fence be erected at once and the windows be cleaned and repaired." According to the article, the grand jury also recommended "better sleeping bunks, the whitewashing of the jail interior and removal of offensive refuse around the jail."

Baseball

On April 5, 1993 the Florida Marlins baseball team played their first game in Joe Robbie Stadium, a 6-3 victory over the Los Angeles Dodgers. A major league baseball franchise had been awarded to Miami in 1991, but the team did not play until two seasons later. In 2011 the team changed its name from Florida Marlins to Miami Marlins.

Remembrances

Claudia Schneider

Longtime historical society member Claudia Jean Davis Schneider, died Jan. 20 following several years of declining health. She was born Feb. 21, 1940 in Atlantic City, N.J. and was raised in St. Lucie County. Her family had been prominent White City residents since the 1920s.

She was a 1958 graduate of Dan McCarty High School and worked in various local businesses. With her keen interest in local history, she was a regular attendee at SLHS dinner meetings and a volunteer at the museum. She also was active in the White City Improvement Club.

She was predeceased by her parents, Claude and Lillian Davis, and by her husband Matthew P. Schneider. Her survivors include sons Michael Schneider, Mark Schneider and Matthew C. Schneider. Also surviving are her brothers Robert A. Davis, Edward Davis and Jeffrey Davis, plus numerous grandchildren.

James Midelis

Judge James William Midelis, a member of one of St. Lucie County's prominent professional and business families, died Feb. 10 at his Fort Pierce home. He was born Dec. 27, 1935 in Paterson, N.J. and came to this area as a boy with his parents Harry and Catherine Midelis.

He was a graduate of the University of Florida and the Florida State University College of Law. His legal career spanned 40 years, including service as a Senior Circuit Judge.

In addition to his parents, he was predeceased by his wife **Gay Midelis** and a son, **Jeffrey Scott Midelis**. He is survived by son **James William Midelis III**, plus several grandchildren.

Joan Ankeny

Former SLHS member **Joan Ankeny** died Feb. 28 at age 89. She was born in Bridgeport, Conn. and had been a registered nurse. Her husband of 70 years, **Rollin F. Ankeny**, a member of a pioneer St. Lucie County family, survives her.

Survivors also include three sons, Rollin B. Ankeny, Douglas L. Ankeny and Bruce H. Ankeny, plus nine grandchildren and 15 great-grandchildren. Δ



Acclaimed Florida environmentalist **Marjory Stoneman Douglas** was born on April 5, 1890. She was raised in Massachusetts and was graduated from Wellesley College in 1912. During her newspaper career in Miami she gained fame with her 1947 book *Everglades: River of Grass*. It became a primary source for understanding the Everglades and stimulated efforts to preserve the vital wetland. She died in 1998 at age 108.
